Independent Auditor's Review Report

We have reviewed the accompanying Statement of unaudited financial results ("the Statement") of JMD ALLOYS LIMITED ("the Company") for the quarter ended 30th June, 2020, being submitted by the Company pursuant to the requirement of regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as modified by Circular No. CIR/CFD/FAC/2016 dated 5th July, 2016. Attention is drawn to the fact that the figures for the corresponding quarter ended 30th June, 2019 including the reconciliation of the net profit for the quarter under Ind AS of the corresponding quarter with net profit for the quarter reported under previous GAAP as reported in these financial results have been approved by the Company's Board of Directors but have not been subjected to review.

A review is limited primarily to inquiries of Company personal and analytical procedures applied to financial data and thus provide less assurance than an audit.
