
We have reviewed the accompanying Statement of unaudited financial results of **JMD ALLOYS LIMITED** ("the Company") for the **quarter and year ended 31st March, 2020**, ("the Statement") submitted to us by the Company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as modified by Circular No. CIR/CFD/FAC/62/2016 dated 5th July, 2016. 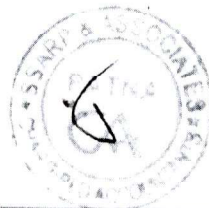

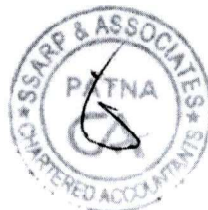
